This Memorandum of Understanding entered into on 12/01/2024 at Bhopal between Technocrats Institute of Technology (Excellence) in front of Hathaikeda Dam, Anand Nagar, Bhopal (hereafter referred to as TIT (E)), imparting and offering educational courses having their headquarters at Bhopal and being represented by its Director which expression shall unless repugnant to the context means and include its successors and assigns of the ONE PART.

And

Centre for Research and Industrial Staff Performance, Bhopal (hereafter referred as CRISP), a registered Society having its registered office Opposite Manas Bhawan, Shyamla Hills, Bhopal, represented through the Director which expressions shall unless repugnant to the context mean and include its successors and assigns of the OTHER PART.

WHEREAS

TIT (E) has agreed to enter into an MoU with CRISP to recognize and conduct various industry/job-oriented courses to be taken up as Industrial/Major/Minor/Vocational Trainings/Faculty Development Programs for the students and faculty members of the various departments of TIT (E), on campus/off campus and offer expertise facilities and infrastructure as may be required by CRISP for various projects for design, analysis and execution as may be the case.

AND WHEREAS

CRISP an autonomous organization under the Department of Technical Education & Skill Development, Government of Madhya Pradesh established under Indo-German Technical Cooperation agreement is engaged in technical consulting & IT solutions and Training in advanced technology areas through tailor-made courses/general comprehensive programmes of training as per needs of the other Party.

The parties have had preliminary discussions in this matter and have ascertained areas of broad consensus. The parties have, therefore, agreed now to include in writing these areas of consensus, under this Memorandum of Understanding.

Now this Memorandum of Understanding witnesses that:

Objective:

The main objectives of the MoU between two Institutions are:

- To exchange of expertise for benefit of both the organizations.
- To impart mutually agreed programs of training to students and faculty members of TIT (E) in relevant field.
- To enhance knowledge, skills, attitudes and awareness among the students in their respective fields of specialization.
- To support students in the development of their Projects.
- To organize skill development courses in specified areas of Advanced Technology and Management Skills.
- To share laboratories for development of innovative projects.
- To facilitate BTech, MTech., MCA & MBA Projects/ dissertation work under joint guidance of the TIT (E) faculty members and experts from CRISP.
- To involve students of TIT (E) in the relevant R&D activities with an aim to transform these graduating and post graduating professionals who are usefully employable by the industry.
- To involve experts from CRISP in identifying specific training needs for students of TIT (E) and designing the modules for corresponding value-added courses in order to bridge the technological gap between industrial requirement and university curriculum.
- To organize Workshops, conferences, FDPs, Seminars and Symposia with joint participation.
- To arrange students' visits to CRISP Bhopal.

Scope of Agreement:

With a view to achieve the objectives set forth in the preceding paragraphs, both parties agree to discharge responsibilities meeting the above objectives.

Implementation Authority: On behalf of CRISP, the Director and on behalf of TIT (E) the Head of Institution (Director) or representative nominated by the Head of Institution shall act as the implementing authority, for operating the various provisions of this MoU on behalf of their respective organizations. All formal communications will be exchanged only through the nominated representatives.

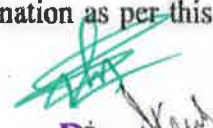
General Terms Agreement:

- Both the parties agree that no action/ failure on the part of either party to in act relation to the above MoU will give rise to serve as the basis for any claim, obligation or liability on either side.
- The courses offered by CRISP could vary or strengthened/ amended from time to time as mutually agreed and new courses could be added in consultations between the two parties.

Validity of this MoU:

This MoU is valid initially for a period of 3 years starting from the date of signing and can be renewed for a further period on mutually acceptable terms & conditions. This MoU can be terminated on either side by giving a **notice of three months** in writing to the other party. This MoU shall also stand terminated if either of the parties is declared as insolvent by a court of competent jurisdiction. Any termination as per this clause shall not affect the antecedent

liabilities of the two parties prior to the termination.

Confidentiality:

In the course of fulfilling the mutual responsibilities under this MoU, there will be a sharing of information of confidential nature. Both parties hereby agree to maintain such information relating to methods, trade secrets, ideas, products, services, processes, techniques and other proprietary information in strict confidence and not divulge such aspects in any manner to any other party besides the top Management.

Notices:

All notices and communications concerning this MoU shall be sent to the respective addresses of the parties as above.

Assignments:

Neither party shall assign any or all their rights and obligations under this MoU without the prior written consent of the other.

Amendments:

Any amendments to this MoU shall be in writing and duly signed by both the parties.

Ownership:

Intellectual property rights, titles of ownership of any products, proprietary information or technology shall not be transferred from one to another on account of use of the same as part of any work under this MoU and shall always remain with the original owner of the same.

Cost:

Both the parties shall bear their respective costs arising out of performance of their obligations under this MoU.

Resolution of Disputes:

Any dispute (s) arising out of or in connection with this MoU shall be resolved amicably between the authorized representatives of both the parties failing which such dispute(s) shall be addressed to a mutually agreed arbitrator whose decision will be final and binding on both the parties.

Commitments:

TIT (E) or CRISP shall make commitments of binding the other party in any manner with any customer only with prior written consent of the other party,

Force Majeure:

Neither TIT (E) nor CRISP shall be liable for non-performance of any or all their obligations under this MoU due to reasons of "Force Majeure" and / or reasons beyond their reasonable control.

Integration:

This MoU contains the entire understanding between the two parties and supersedes any

prior written or oral-MoUs between them.

Waiver:

No failure or delay on the part of either party in exercise of any right or privilege hereunder shall operate as a waiver thereof or on the exercise of any other right or privilege hereunder, nor shall any single or partial exercise of any such right or privilege preclude the other or further exercise thereof in respect of any other right or privilege.

Severability:

If any provision of this MoU is held to be ineffective, unenforceable of illegal or any reason, such decision shall not affect the validity or enforceability of any or all of the remaining portions thereof.

Non-Solicitation:

During the terms of this MoU or its termination, neither party shall, without the prior written consent of the other party, canvass or solicit for direct or indirect employment of any employee of each other or proceed with any application by or on behalf of that employee for direct or indirect employment. Neither party shall procure any third party to do any of the aforesaid acts.

Both the parties shall exchange between themselves the information as and when required, by any one or both Viz. PAN Details, Service Tax details etc.

ARTICLE 2: COORDINATION

Either organization shall appoint one member to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of **ELITE ARCH GROUP** and a program coordinator from the side of **TECHNOCRATS INSTITUTE OF TECHNOLOGY (EXCELLENCE)** will periodically review and identify ways to strengthen corporation between the two organizations.

ARTICLE 3: VALIDITY

The MoU shall remain in force for a period of **Five years** commencing from 02/12/2023. Organizations may extend the term by written agreement signed by both after review.

ARTICLE 4: TERMINATION

AND

Technocrats Group (Technocrats Institute of Technology, Technocrats Institute of Technology (Excellence), Technocrats Institute of Technology & Science, Technocrats Institute of Technology - CSE), an entity (Section 8 Company) registered under the law of India and having its registered office address Technocrats Group (Technocrats Group Campus, Anand Nagar, BHEL Bhopal-462021 Madhya Pradesh, India) (hereinafter referred to as "**Second Party**" or "**Technocrats Group**" which means and include, unless repugnant to the context or meaning thereof mean and include its liquidators, successors, receivers and assigns) of the **OTHER PART**;

"**First Party**" or "**TIDES**" and "**Second party**" or "**Technocrats Group**" are hereinafter individually and collectively referred to as "**Party**" and "**Parties**" respectively, as the context may require.

TIDES & Technocrats Group agrees that cooperation in the Entrepreneurship, Startups and Incubation area would be mutually beneficial in order to promote entrepreneurial, research, educational and academic exchanges, and collaboration.

III. Designated Liaison Officials - **Technocrats Group** and **TIDES**, shall each designate to the other, within thirty (30) days after the execution of this Agreement, the liaison official(s) authorized to endorse exchanges and other collaborative

IV. Termination - This Agreement may be terminated by either party providing the other written notice of its intent to terminate. Such notice shall be given at least one (1) year prior to the effective date of the termination and all the registered startup brought by TIDES will remain with **Technocrats Group**.

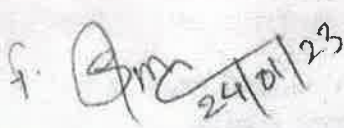

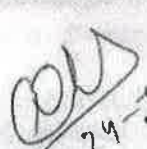

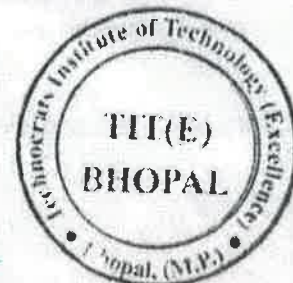

- a. This Program Sponsors shall be the Vice Chancellor//Dean / Head of Department from the College and Head- Revenue Assurance from Hexaware.
- b. The 3rd year students to be trained shall be pre-selected by Hexaware (hereinafter referred to as the 'Pre-selected Students') as per Hexaware's selection process and a Letter of Intent (LOI) will be given to the pre-selected students which will specify the conditions to be complied with in order to join the organization.
- c. The pre-selection is primarily for the Graduate Engineer Trainee (GET) category. Top performing students from the training program who qualify may be selected as Premier Graduate Engineer Trainees (PGETs), subject to company policy. Hexaware will have the final call based on the individual performance in this regard. All final selections for offer will be subject to selection in the final Hexaware recruitment process.

- h. The Pre-Selected students in their 6th Semester, will have to complete the Foundation course consisting of both Soft skills and Technical Skills. On successful completion of the Foundation course, they will undergo a specialized training under the Centers of Excellence identified by Hexaware for the College and obtain their certification in their 7th Semester.
- i. The course will be imparted for the duration specified by the Hexaware as an additional training program. This program will be run during the 3rd year of the graduation course being offered by the College for the Pre-selected students.
- j. The College shall not charge the Pre-selected students any fee for this course. If it is found that the College has charged fees for this program from students, Hexaware shall have the rights to terminate this MOU and/or pursue other remedies available under the law, against the College.

Confidential Information shall mean all proprietary information or data furnished by either Party and/or its affiliates before or after the Effective Date hereof, whether written or oral which includes but is not limited to Parties' trade secrets, processes, devices, designs, concepts, improvements, know-how, algorithms, models, inventions (whether or not patentable or copyrighted), developments, decision technology, specifications, techniques, sketches, works of authorship, applications processes, strategies, designs, photographs, profile of its subsidiaries, branches or details of shareholding, financials, projections, track record, profile of product, any data or information regarding either Parties employees, prospective employees, business objective / criteria, employee lists, employee profiles, employee information, and other documentation relating to past, present or future business activities and services, which is disclosed by the Party within thirty (30) days of the disclosure and which was designated as 'Confidential' or with a similar legend at the time of disclosure.

Both Parties agrees and confirms that it shall not use, share, and reveal any Confidential Information provided by either Parties for any purpose other than for rendering Services under this MoU and provide it only on a need to know basis to its Personnel (including subcontractors wherever applicable) for provision of Services under this MoU with prior written permission from the other Party. The Parties will ensure that all Personnel assigned to provide the Services under this MoU have signed appropriate confidential and non-disclosure agreement (with terms no less onerous than terms appearing in this MoU) to ensure either Parties Confidential Information disclosed under this MoU is protected from unauthorized use and disclosure. Both Parties hereby assumes full liability for the actions of its Personnel who have access to the Confidential Information provided by each other and agrees that it shall be liable for all such actions as though those actions were the actions of the other.

Save as permitted in clause above:

- either Party shall not mention or otherwise use the name or trademark of each other or its affiliates in any publication, press release, promotional material or other form of publicity without the prior written consent of the appropriate individual designated for the purpose by concern Party;
- the receiving Party shall take all steps as may be reasonably necessary to protect the integrity of the Confidential Information and to ensure against any unauthorized disclosure thereof;
- promptly inform the other of any potential or accidental disclosure of the Confidential Information and take all steps, together with the aggrieved Party, to retrieve and protect the said Confidential Information;
- use the Confidential Information only for the purpose for which it was provided and not profit from the same in any unauthorized manner to the exclusion of the disclosing Party.
